EXEMPTION VIGNETTE & NATIONAL INSURANCE NUMBER

DOD Military members and command-sponsored dependents do not require a visa upon entry or for their duration of time in the United Kingdom. Instead, they require an exemption vignette. The exemption vignette which acts as a Visa allows dependents (spouses and children under 21 years of age) of military members to show immigration exemption for the duration of their sponsors' tour. An exemption vignette is highly encouraged for military dependents who will be seeking off-base employment, schooling, renting property, etc. **It is required for employment on the local UK economy.** The vignette is free and will be placed in the no-fee passport or official passport. The checklist on the RAF Alconbury Passport site (see page 8) will work for both passport locations as there is not an associated application.


Sometimes, DOD Civilian dependents do not need the exception vignette, but it is highly encouraged.

You must also apply for a National Insurance Number (NIN) when hired for work for off-base employment. This number is a unique identifier used by the UK government to keep a record of your tax and benefits entitlements. Your National Insurance Number remains the same for life. It's made up of 2 letters, 6 numbers and a final letter. It can take up to 4 weeks to get your NIN. *You can start work before you receive your assigned NIN if you can prove the right to work in the UK

 - DEROS (end of UK tour date)

Additional Requirements For Dependent(s) Not On Original PCS Orders:

- A. Children Born in the United Kingdom
 - British birth certificate (long green form) or Consular Report of Birth Abro ad (CREA)
 - Approved command sponsorship memorandum (from MPF Career Development) or sister service equivalent
- B. Mil-to-Mil Member Who Separates/Retires and Becomes a Dependent
 - Applicant's approved separation/retirement orders
 - Approved command sponsorship memorandum (from MPF Career Development) or sister service equivalent
- C. Acquired Dependent (s) i.e. new spouse, adopted, step-child, secondary dependency determination, etc.
 - · Approved command sponsorship memorandum (from MPF Career Development) or sister service equivalent

As part of the Status of Forces Agreement (SOFA) command sponsored family members (military or civilian) with a visiting forces dependent visa and no employment restrictions on their passport are able to work on the British Economy without a work permit. You must apply for a National Insurance Number when hired for work.

If you are NOT command sponsored, you may receive componency status, which allows you to purchase gas on base and shop at the BX and commissary by working a certain number of hours per week for AAFES, HRO, and DECA. Contact these agencies to get more information on componency. If you choose to work offbase you will not have entitlement to the base, and you will have to obtain a work permit and work visa.

It is important to note, when you are PCSing back to the US, you must do the following:

Obtain a P-45 from your employer. Go to www.hmrc.gov.uk. Go to individual forms and under "Leaving the UK" sections, print out the P-85 Form. Find out where your employer's tax office is located and send the P-85 and -45 forms. It takes 6-8 weeks to get a refund. Refunds are either directly deposited into your pound sterling account or a pound sterling check may be mailed to your forwarding address. Licensed professions

Nursing

Many nurses who have obtained US degrees are not automatically granted reciprocity for the UK. To work in England, nurses must be registered with and accredited by the UK Nursing and Midwifery Council (NMC). To apply for English 'qualified teacher status', or be able to demonstrate strong non-UK qualifications and experience, the following is needed: a high standard of written and spoken English, to pass criminal and professional safeguarding checks (these will be organised by your employer), & a visa or immigration status allowing you to work in the UK.

REMOTE/TELEWORK

U.S. Government Telework

Dependents may also be eligible to work remotely for U.S. government agencies via Domestic Employee Teleworking Overseas (DETO). An approved DETO agreement allows U.S. Government direct-hire employees, that are assigned to U.S. domestic positions, to telework from an overseas location. DETOs are not assigned to the overseas location but are given a temporary duty location while overseas.

Visas

Dependents working under a DETO agreement will not require a visa. Exempt vignettes are recommended but not required.

National Insurance Number

Those working for the U.S. government under a DETO agreement will be working under U.S. conditions, and as such, are **not required** to obtain a national insurance number.

Taxes and National Insurance Payments

As individuals will be employed under U.S. conditions, they will remain in the U.S. tax and social security system, meaning there are no obligations to make additional payments into the UK system. U.S. Company Telework (Non-Government)

Dependents working privately in the U.S. may wish to continue working for their employer remotely while in the United Kingdom. This may be an attractive prospect for individuals and employers. However, it is important to understand that the employer will be responsible for ensuring that their employee is working legally in the UK. For example, this may require the employer to establish a business presence in the UK or transfer the employee to an established UK branch so that they can work under UK conditions. Dependents seeking this form of employment should discuss this with their employer, as the base legal offices will likely be unable to assist.

SELF-EMPLOYMENT

Self-Employment

Dependents may also wish to work for themselves, for example by starting a small business or continuing a trade. Those wishing to do so will need to ensure they comply with any applicable UK regulations and fully understand all the rules and obligations that may apply to them.

Visas

The same visa exemption applies to military dependents who wish to create or run their own business while in the UK. Obtaining an exempt vignette remains highly recommended so that the individual has an easy method of proving their right to work in the UK if required.

National Insurance Number

It will still be necessary to obtain a national insurance number so that payments and taxes can be properly filed.

Taxes and National Insurance Payments

Those who wish to work on a self-employed basis will usually need to register with the UK's tax authority, His Majesty's Revenue and Customs (HMRC). Individuals can register themselves as "Sole Traders." Sole traders will need to file UK tax returns, keep proper records and ensure that any obligations such as income tax and national insurance payments are met. Alternatively, individuals can create "limited companies" or "business partnerships." These also require registration with the UK government agency "Companies House." The advantages and obligations associated with this require careful consideration.

Operating a business in the UK can be a very complex matter and may depend highly on individual circumstances. It is important to fully understand the obligations that come with each method of registration before commencing a business. As such, it is highly advisable to first obtain independent advice.
